An Agreement has been entered into between South Western Railway & JSW Minerals Rail Logistics Private Ltd. on 17.10.2023 for operation of 07 BOBS-NS (Hopper wagon), Special Type of Wagon with side discharge arrangement for unloading / loading of Iron Ore from the mines at Mineral Enterprises Ltd Siding, Sasalu & Swamihalli to the steel plant of JSW at Toranagalu. This is the first kind of Agreement in SWR. The rake is manufactured by M/s. Titagarh Rail System Limited, Kolkata & the first rake is expected to be operative from April-2024. M/s. JSW Minerals Rail Logistics Private Ltd. is investing Rs. 29.57 Cr per rake. A rebate of 10% is granted to the customer on base freight for every booking. Introduction of BOBSNS (Hopper wagon) will ease out the unloading difficulty through wagon tippler or manually. The Agreement has been signed by A.
